**"IMPORTANT:** Please read carefully the provisions below governing the duties of the Agency and Private Security Personnel. By receiving this LTO, the licensee shall be deemed to have read and understood the rules and regulations that are embodied herein, to wit:

- a. The management of the Agency and their deployed security guards shall be duty bound to assist any PNP member or other law enforcement officer of his bounding duty, when requested, provided it is within the territorial jurisdiction of the security guard's area of duty and that the agency is covered with a valid Security Contract/Agreement with its client; and
- b. In case of emergency or in times of disaster or calamity, the Chief, PNP may deputize any private security personnel to assist the PNP in the performance of their duties for the duration of such emergency, disaster or calamity. Likewise, when emergencies arise, the City or Municipality Mayor may muster or incorporate the services of the agencies nearest the area of emergency, disaster or calamity and its duty private security personnel to help maintain peace and order, prevent law violations and preserve life and properties. The deputized private security personnel shall take order from the Chief of Police of the City or Municipality for the duration of the emergency, disaster or calamity."


